**Subject: 220kV AIS Substation Package for construction of two Pooling substations (PSS1 & PSS2) of 33/220 kV capacity and 220 kV transmission lines up to 220kV side (incomer) of 220/400 kV Grid Sub-station (GSS) to evacuate power from 500MW & 300MW capacity block Solar Park Project at Mau, Chitrakoot (U.P.)**

**1.0** M/s. TUSCO Limited (a JV of THDCIL and UPNEDA) having its Registered office at 4<sup>th</sup> floor, UPNEDA Bhawan, Vibhuti Khand, Gomti Nagar, Lucknow-226010 (U.P) (hereinafter referred to as 'TUSCO'/'Owner'/'Employer') has decided to execute, as an Owner, invites bids from the eligible bidders under Domestic Competitive Bidding through e-tendering for the subject work under "Two Part Bid System" followed by e-RA in accordance with the following details and enclosed Bidding Documents:

**2.0** The bidder must meet the pre-qualification requirement as given in Bid Document **Annexure-(A) BDS**.

**3.0** No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries/ Pre-Bid Conference (if applicable) as specified above.

The Bidders are advised to visit and examine the site before the pre-bid meeting where the facilities are to be installed and its surroundings and obtain for itself on its own responsibility and cost all information that may be necessary for preparing the bid and entering into a contract for supply and installation of the facilities. The costs of visiting the site shall be at the Bidder's own expense.

4.0 Bids are invited through e-tendering by uploading and submitting the same on CPP (Central Public Procurement) e-procurement Portal website <http://eprocure.gov.in/eprocure/app> .

5.0 The complete Bidding Document is available on CPP e-procurement Portal website <http://eprocure.gov.in/eprocure/app> . The bidder may download the Bidding Documents accordingly after bidder registration.

6.0 All future amendments/ corrigendum/ addenda/ clarifications, if any, shall be uploaded on the website <http://eprocure.gov.in/eprocure/app> only. Bidders shall keep themselves updated with all such amendments/ corrigendum/ addenda/ clarifications.

- 7.0 The Bids are invited under Two-Part Bid System followed by e-RA. The first part (Part-I) called “PQ and Techno-Commercial Bid” shall contain Bid Security (EMD), Pre-qualification information & documentary evidence in support thereof and Techno-Commercial Information. The Part-I (PQ and Techno-commercial Bid) and Part-II (Price Bid) are to be uploaded & submitted on CPP Portal website- <https://eprocure.gov.in> only in the prescribed format. **No hard copy of the Price Bid (Part-II) shall be accepted.** e-RA details are given in bidding documents.
- 8.0 Bidders are requested to read the ‘Bidders Manual and Pre-Requisite Document’ available on ‘Reverse Auction’ portal through as per term and condition of CPP Portal before proceeding for submission of bids. It is important to note that bidders can submit their bids online only through CPP Portal <https://eprocure.gov.in>. Kindly refer the Annexure-B (BDS) document for reverse auction.
- 9.0 Soft Copy Part of the Bids must be uploaded under Two Part Bidding Procedure on the portal at or before **15:00 hours** on **23.04.2025**. The e-Procurement system would not allow any late submission of bids through the portal after due date & time as specified.
- 10.0 Hard Copy Part of the Bids must be submitted under Two Part Bidding followed by e-RA Procedure at the address given in BDS at or before **15:00 hours** on **24.04.2025**. **In case Hard copy part of the bid is not received by the Employer till the deadline for submission of the same prescribed by the Employer, but the bidder has uploaded the soft copy part of the bid, the soft copy part of the first Part (Part-I) bid uploaded on the portal shall be opened.** Such bids will be rejected during preliminary examination.

First Part (Part-I) i.e. PQ & Techno -Commercial Part shall be opened on **24.04.2025** at **15:30 hours** in the presence of the bidders’ representatives who choose to attend in person at the address below Second Part (Part-II) i.e. Price Part shall be opened in the presence of the bidders’ representatives who choose to attend at the time and date and at the address given in the intimation for opening of Second Part (Part-II) in accordance with Clause 25 of ITB.

**Document Fee, Power of Attorney, Bid Security, Joint Deed of Undertaking (if applicable), No Deviation Certificate, Joint Venture Agreement (if applicable), Safety Pact & Any other document further specified in the BDS duly signed and stamped on each page** must be submitted in physical form at the address given at para 17.0 below at or before **15:00 hours** on **24.04.2025**. This envelope shall bear the submission address and due date / time and clearly marked, **“DO NOT OPEN BEFORE 15.00 Hrs on ..... (TUSCO/CSPP/IPEI/2024-25/11)”**. TUSCO shall not be responsible for any postal delay in respect of submission of hard copy part of the bids. The scanned copy of all these documents should also be uploaded in the website. Any bid not accompanied by original hard copy of above documents by the stipulated date and time the bid may liable for rejection by the Owner.

11. Conditional Bid may run the risk of rejection.
12. The bidder shall be a private, public or government owned legal entity.
13. Notwithstanding anything stated above, TUSCO Limited reserves the right to assess the capabilities and capacity of the bidder to perform the contract, should the circumstances warrant such assessment in the overall interest of TUSCO Limited .

14. TUSCO Limited reserves the right to reject any or all the bids or cancel/ withdraw the invitation for bid, enhance or dilute the Pre-qualification criteria, in the overall interest of TUSCO Limited, without assigning any reason whatsoever and in such case no bidder/ intending bidder shall have any claim arising out of such action.
15. A complete set of Bidding Documents may be downloaded by any interested Bidder from the CPP Portal website- <https://eprocure.gov.in>. The tender is invited under e-tendering process. The bidders can enroll themselves on the CPP Portal website- <https://eprocure.gov.in> using the option “Online Bidder Enrolment”.
16. Any ‘Bidder from a country which shares a land border with India’, as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
